Race 1, All clear

Race 2, reviewed start of # 4Sea To Air, I. Mosqueira, 4th, the assistant starter on the offside, #5 stall did release the horse at the time the starter dispatched the field, received a fair start, but was slow as #3 Mia an Me, M. Pinto, 1st, does fill the void by baring out. Reviewed urging by Mr. Mosqueira, raising hand above head level when making contact with his mount, with the crop.

Was cautioned previously on May 31, 2026. Is a second violation within a calendar year, 1 day suspension, \$300.00 monetary penalty. Day to be determined.

Race 3, All clear, spoke with Jockey Kirk Johnson, raised up in the irons prior to finish, he stated that she had displaced, breathing, and was shutting down, felt it in the best interest of welfare to the horse to do so, accepted the explanation, it was observed the horse was not able to gallop out very far into the far turn. Rest ok.

Race 4, Turf, All clear, Jockey Ismael Mosqueira excuse from the remainder of his mounts.

Race 5, All clear

Race 6, Late Steward scratch of #3 Ondine Lady, would not go forward after being saddled, very unruly and in the best interest of safety for all involved Ondine Lady is a Steward scratch. Refund of \$3,590.00. Race all clear.

Race 7, Turf, late Steward scratch of #2 Rescue That Girl, reared in gate prior to start, refund of \$1st Inquiry, Jockey claim of foul, #5, Wet and Wild, Brian Cheyne, 8th, on #8 Star Scholar, Steve Jadoo, 3rd, run into the first turn, upon review of the upper pan and front tower camera angles, #5 is in behind horses as they run into the clubhouse turn, #8 is having difficulty navigating the turn, as there is inside pressure, claim of foul disallowed.

2nd Inquiry, #7 Mannix, J. Crawford, 2nd on #6 J P Hellish, D Gaskin, 1st approaching finish, upon review of the upper pan and front tower camera angles, #6 on the inside does come out to the #7 and #7 does come in a step, #6 has gained the advantage of #7 prior to the contact, claim of foul is disallowed.
