R1: JCOF: #2 "Cantucci" (B. Cheyne – 4th PI 3rd) and #3 "Commander Joe" (H. Vanek – 5th) on #1 "Galvaston" (P. Mailhot 4th PI 3rd) alleging interference in upper stretch. Spoke with all three riders and reviewed all video angles. #1 drifts outwards coming out of the turn the turn into the path of #2, who is squeezed between #1 and #3 and loses some momentum. #3 has more space to the outside and is not impacted. As a result, #1 is disqualified from 3rd and placed 4th behind #2.
